# COMMISSIONER'S CORNER

## Changes in Dues Structure Proposed

Introduced at the January 22 Council meeting, league representatives discussed a proposal that bills schools only for sports ũelded, not on a per-pupil basis.

Since the 1920's Southern Section has received a portion of its revenue from school dues. Fashioned as a method to support the organization when income from the Section Track Meet fell short of projections, the dues have increased from \$.05 per student to \$.23 per student over the span of eighty years. The present per-pupil fee has not changed since 1987!

Under the per-pupil system, schools with large student bodies contributed the bulk of revenue to Southern Section (dues constitute 14% of total revenue) although, in most student bodies, about 40% do not participate in sports. Dues were difficult for financial clerks to calculate because CBDS numbers from the previous year served as the basis for the calculation.

Under the proposed system, the number of sports offered serves as the basis for calculating dues. Sports like basketball must be counted as two sports if both genders are served.

Preliminary calculations show that our large schools will benefit because of lower dues. Small schools will not suffer inordinate increases and will only pay for those sports they offer.

Here is a chart showing the impact on schools of selected sizes:

The Southern Section Executive Committee has endorsed the proposal and Council has received it favorably. By simplifying the dues structure the Section offers ease of use, simplified accounting and equitable payment, based on the sports offered at each school. The proposal is scheduled for a vote on April 21, 2009.

### Streamlining Paperwork Electronically

In the interest of better serving the CIF-SS membership, we continue to improve the way we do business. We are always looking for more efficient procedures in the paperwork process and collection of information that will make everyone's job less time consuming.

With the anticipated requirement of paperwork for all transfers (this will be new in the 2009-2010 school year), including valid changes of residences, we want to remind you of the adjustments the CIF-SS has made to make this process cleaner and more convenient. This year, we went to excel paperwork with fields that can be typed into. Instead of handwriting your transfer paperwork (207 form) and pre-enrollment contact affidavit (510 form) as well as playoff information materials, those can/should be done directly on your computer. We encourage you to take advantage of this as the only fields we require to be handwritten are the signature portions of those forms. Not only are they more legible, especially when they've passed through the fax a few times, they are easier to store for your own records. We encourage schools to do this electronically and keep an electronic file for your reference.

As a side note, the CIF financial forms are also in the excel format. Simply supply the form with the specific information and all will be calculated for you. This includes your sport fee paperwork as well as your revenue sport information.

All paperwork requiring CIF-SS office review is posted at [www.cifss.org](http://www.cifss.org) and reflects approval information. Here you can review paperwork submitted for transfers, valid change of residence, hardships as well as foreign student applications. Although more time is needed for the receipt and/or processing of completed hardship information, a school or family can monitor that their paperwork has been received and once

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING - August 14, 2008

This meeting of the CIF Southern Section Executive Committee was called to order at 1:05 p.m. by President Sr. Cheryl Milner. All members were present with the exception of Susie Arce, Janet Berardi, Jerry Halpin and Reggie Thompkins. In attendance as guests were: Ronald Dautat, Headmaster Ribet Academy, Roger Huff, Athletic Director and William Middlebrooks, Basketball Coach.

### 1. OPENING BUSINESS

E. Adopt Agenda – It was moved, seconded and approved to accept the agenda with the following changes: remove Dominguez High School from old business because they have requested to attend the September Executive Committee meeting; move item 5.A.2 Ribet Academy to the beginning of action items; remove item 3.B.A. from action items to old business and to also move the approval of Carter Paysinger, Athletic Director of Beverly Hills High School as the Coast Area Representative item 6.E to the beginning of the meeting. After discussion, it was moved, seconded and approved to appoint Carter Paysinger as the Coast Area Representative.

F. Approval of Minutes – Minutes of the May 21, 2008 Executive Committee Meeting – It was moved, seconded and approved.

G. Communications to the Executive Committee – Sr. Cheryl mentioned a letter that was received acknowledging Rob Wigod's participation at the Sports Officiating Summit in Cleveland, Ohio. She thanked Rob for his commitment to officials.

### 2. PUBLIC HEARING SESSION

There were no members of the public in attendance; the agenda was posted.

### 5. OLDBUSINESS

A. Sanctions Appeal – Ribet Academy was represented by Ronald Dautat, Headmaster, Roger Huff, Athletic Director and William Middlebrooks, Basketball Coach.

After lengthy discussion, it was moved, seconded and approved unanimously to uphold the sanctions levied on the school and deny playoffs for boys basketball during the 2008-2009 school year. Mr. Luketic and Mr. Haugen thanked the representatives of Ribet for attending the meeting and presenting their explanations.

### 3. ACTION ITEMS

#### B. Southern Section Action Items

1. Proposals from Public/Private Open Forum Committee

Dr. Dahlem presented an overview of the discussions of the Public/Private Open Forum Committee. It is a group of very committed administrators from a broad group of public and private schools who discussed all of their concerns.

a. Proposal to Article 50, Rule 528: Financial Aid/Grants/Scholarships – After discussion, it was recommended to place this item under Bylaw 510 Undue Influence. It was also recommended that these items be returned to the public/private committee to be rewritten to cover all comments and recommendations from the Executive Committee. This item will come before the Executive Committee on September 25 as a non-action item.

b. Proposal to Article 50, Rule 529: Public/Private Open Forum Committee – After

discussion, it was moved, seconded and approved to empower the Commissioner to include the Public/Private Open Forum committee as one of the Commissioner's included in the Blue Book and Directory.

c. Proposal to Article 50, Rule 507: Coaching Compensation – This item was discussed and will come back to the Executive Committee on September 25<sup>th</sup> as a non-action item.

d. Proposal to Article 20, Rule 222: Private School Attendance Boundaries – This item was discussed. The public/private committee felt there was nothing that could be done about this issue. They presented their concerns but do not want to move forward with it.

e. Proposal to Article 3, Rule 32.6: Criteria for Addressing Cases of Competitive Equity – The idea of competitive anomalies was discussed. This item will come forward on September 25<sup>th</sup> as a non-action item.

2. Proposal for Water Polo Regional Playoffs – The Water Polo Advisory Committee requests the Masters tournament evolve into a State Regional Tournament, including San Diego, Los Angeles, Central and Southern Sections. It was moved and approved to bring this proposal as an action item before Council on October 23<sup>rd</sup>.

### 5. OLD BUSINESS

#### A. Sanctions Appeal

1. Dominguez High School requested to postpone this appeal to the September 25<sup>th</sup> Executive Committee meeting. Sr. Cheryl Milner stated out of respect for the process, they will hear them in September.

3. Proposal from Century League to revise Bylaws 3200.1 and 3200.2: All Playoffs Managed by Commissioner – Public/Private Playoff Separation – This item was on the agenda because the issue is still active. According to Mr. Halpin, the item may be brought back to the January 22<sup>nd</sup> meeting of Council.

B. Proposal for Soccer Penalties involving Red Cards – This item was discussed.

### 6. NEW BUSINESS

A. New Council Proposal Form – Protocol – Dr. Staunton explained the new form and process.

B. Report from Commissioners on Changes to Blue Book – Ms. Palle discussed how the deletion of the Association Rule will be documented in the Blue Book and the areas affected.

C. Electronic Forms for Schools – Mr. Carty discussed the new forms created for payment of dues and financial reports.

D. Coaching Education Certification – This was a reminder to all schools and coaches that December 31<sup>st</sup> is the deadline for coaching education training. There may be penalties if training is not completed.

E. Appointment of Executive Committee Member – Addressed earlier in meeting.

F. 2008-2009 CIF State Meeting Schedule – Revised calendar was included for information only.

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING - September 25, 2008

This meeting of the CIF Southern Section Executive Committee was called to order at 1:17 p.m. by President Sr. Cheryl Milner. All members were present with the exception of Wendy Doty, Earl Haugen, Larry Satterfield and Debi Weiss. In attendance as guests were: Dr. Burnside, Superintendent, Compton Unified School District, Dr. Gunn Marie Hanson, Assistant Superintendent, Compton Unified School, Chief Taylor, Chief of Police, Compton Unified School District, Ms. Joy Bramlette, Principal, Dominguez High School, Larry Todd, Principal, Lone Pine High School and Roger Blake, CIF State office.

### 1. OPENING BUSINESS

E. Adopt Agenda – It was moved, seconded and approved with the following adjustments:

Item 5A, Dominguez High School Sanction Appeal and item 6A, Lone Pine High School Appeal to be moved after the Public Hearing Session.

F. Approval of Minutes – It was moved and seconded to approve the minutes of the August 14, 2008 Executive Committee meeting.

G. Communications to the Executive Committee – Carter Paysinger, Athletic Director, Beverly Hills High School was introduced as the Coast Area Representative.

### 5. OLDBUSINESS

A. Sanction Appeal – Representing Dominguez High School were Dr. Burnside, Superintendent, Dr. Gunn Marie Hanson, Assistant Superintendent, Chief Taylor, Chief of Police and Ms. Joy Bramlette, Principal. Dr. Staunton summarized the sanction against Dominguez High School; the issue of timely payment of dues and delinquent financial reports. Bylaw 145 was invoked and Dominguez High School will not be allowed to host a home game during the playoffs in all sports for a period of one year.

Dr. Burnside requested CIF to remove the sanction for the benefit of the students who should not be held responsible for the action of adults. She stands for what is right and not paying dues on time will not continue in her district. Dr. Hanson stated the district recognized they needed to hire one person to oversee athletics. They are going to hire a school financial technician and will have school police on site to monitor ticket sales and receipts. Ms. Bramlette stated CIF can depend on Dominguez High School to live up to high standards from now on. Their seats in the gym will now be numbered and all employees will pay for their tickets. Chief Taylor stated the person who handled the ticket sales has been removed from campus and is under investigation. They insure that future monies will be collected and deposited in the proper places. They all asked CIF to let them show that what has happened in the past will not happen from now on.

After discussion, it was moved that CIF support Dominguez High School's appeal to host playoff games. There was no second. After further discussion, it was moved that CIF deny the appeal; it was seconded and approved. It was also discussed that if progress is made by the district, another appeal may be considered.

### 6. NEWBUSINESS

A. Representing Lone Pine High School was principal, Larry Todd. Lone Pine High School requested multi-school team status with Sierra Alternative Learning Academy. Dr. Staunton stated after receiving all of the required signatures, the league denied it and that is the reason Mr. Todd is appealing. This school is a continuation school and by our rules, is not allowed. Jim Boghosian, Boron High School athletic director and the Desert Mountain league representative was unable to attend the meeting, explained the league did not sign because of Rule 303.C.5.a and b.

Mr. Todd stated this community day school was created three years ago by his board of education. It was set up as an option to the high school. His appeal was about giving opportunities to succeed. Students who have athletic opportunities perform better. Mr. Todd explained the operation of the school. The students attend school all day and they will be accredited. He does not see this as a continuation school and there are two or three students who would like to participate in athletics.

Dr. Staunton stated the point of contention is that this is a continuation school. Mr. Todd included criteria for a continuation school and a day school and is unaware of what the league knows about this program. They look at it as a learning option. Most of the students are at this school for credit retrieval as they are 30-40 credits behind. They are there to go back to the local high school or to graduate. They probably would not attend the member school for one period a day. They are funded as a community day school which allows them to take students younger than 16 whereas continuation schools only take children 16 years and over.

After further discussion, it was moved to deny the appeal from Lone Pine High School. It was seconded and approved to deny the motion.

### 4. NON-ACTION ITEMS

B. Southern Section Non-Action Items  
1. Proposals from Public/Private Open Forum Committee –

a. Article 50, Rule 528 – After discussion, it was moved to have the proposal read as follows:

“Financial aid, grants or scholarships given to students based on athletic prowess is prohibited.” The motion was seconded and approved.

b. Article 50, Rule 5007 – After discussion, it was moved to have this proposal read:

“All member schools will, upon request, submit to the Southern Section office, their financial pay structure for coaches' stipends adopted by the governing board.”

c. Article 3, Rule 32.6 – After discussion, it was moved to send this proposal back to committee. It was seconded. After further discussion, this motion was revised to read as follows: It was moved to send this proposal back to the committee until the area placement

## OFFICIALS' WHISTLE

Officials Belonging to a single or Multiple association for any one sport – and implication

The Sothern Section makes it a practice to assign neutral officials in Finals contests. Neutral is defined as officials who are not from the local assigning unit of Teams involved in the final event. Neutrality or impartiality of officials is a basic premise of all sports – the arbiters should not be affiliated with either Contestant.

One unique aspect of current day officials is that they often are affiliated with multiple units or officials' agencies. For example in Basketball it is not unusual for officials to belong to 2-3 units. Since units are usually based on a geographic area, this mean that many officials will cross over cities and counties and find work at a variety of schools. Similarly in Tournaments and other feature events, officials are recruited from a wide area and brought in for there expertise.

Future options may allow for greater movement of officials. Allowing Officials this flexibility would have pros and cons, but it would certainly address those areas with official shortages and lessen the probability of the same official returning to the same school too often.

Administrators, coaches, players and family have come to recognize certain officials and that in many cases is a good thing. Officials are an important part of the game and at best they should be properly noticed.

The full implication of officials associated with multiple areas is yet to be evaluated. There seem to be many positives as we continue the effort to standardize officiating and make our games better

### 1. OPENING BUSINESS

E. Adopt Agenda – It was moved, seconded and approved with the following adjustments: add item 5C, Request from Grace Brethren.

Earl Haugen introduced Lee Meach and Wayne Choo of the Carmody, Meach and Choo Auditing Firm.

F. Approval of Minutes – It was moved and seconded to approved the minutes of the September 25, 2008 Executive Committee meeting. The motion was approved.

H. 2007-2008 Auditor's Report – Lee Meach presented the auditor's report. Earl Haugen stated there was a clean audit with one exception regarding CalPers. CalPers will not give out individual account information. As a result, we have a glitch in our audit. Mitch Carty will pursue any action we can take. Mitch stated this was new during 2007. 2. Penalties: Failure to Comply with Article 22.B – This item is for information purposes only. Failure to comply with this article may cause suspension. It is a progressive discipline if coaches are not certified.

#### 5. NEW BUSINESS

A. Bona Fide Change of Residence Form – Jim Staunton discussed this form. Most schools comply and send the forms to us, however, there are some schools who are not sending the information in or families who are falsifying information. We would like to add it to Form 207 and "effective (date), all Bona Fide Change of Residence Forms must be submitted." Adding this to Form 207 – Athletic Transfer Eligibility Application, will include caveats to swear the information is true. The staff will mock up a new form and present it at the next Executive Committee Meeting.

B. Awards Presentations at Football Championships – Rob Wigod requested all Executive Committee members assist at football championships by presenting awards at the championship finals.

C. Request from Grace Brethren High School – Jim Staunton stated four years ago, Grace Brethren requested to go to the Northern Area. They were late submitting their form,

which was due on October 3, and asked it to be heard; it was denied. Dr. Staunton advised them they missed the deadline for submission but would allow the Executive Committee to make this decision. It was moved, seconded and approved to deny the request with one opposing vote.

#### 6. REPORT SESSION

A. President's Report – Sr. Cheryl Milner stated the Champions for Character luncheon was wonderful. There is a possibility that next year we may separate it from the Council meeting.

B. There was no treasurer's report.

C. Commissioner's Report – Jim Staunton stated he met with the assistant superintendent of Compton Unified School District who was concerned about what is being said to the media. In their discussion, Dr. Staunton also stated he would like to have an audit of their schools. It is time to put the proper checks and balances of eligibility into place for their athletes. We will move forward as this will be very positive. Dr. Hanson was accepting of this and we will talk with their superintendent. We suggested they hire former administrators of CIF to teach them how to handle all of the CIF paperwork. As of this meeting, Dominguez High School had not paid their dues.

D. Executive Committee Member Reports – There were no reports given.

There being no further business, the meeting adjourned at 2:45 p.m.

## CSADA 41st ANNUAL CONFERENCE SET FOR APRIL 2009

The California State Athletic Directors Association's 41<sup>st</sup> Annual Conference returns to Southern California and the Town and Country Resort & Convention Center in San Diego, Wednesday-Sunday, April 22-26, 2009. The conference, themed *Partners in Education - Academics and Athletics*, annually draws close to 700 athletic directors and administrators from across the state and will be headlined by several new and exciting speakers.

As always, the Saturday night awards dinner will be one of the highlights of the conference with this year's keynote speaker, Hugh McCutcheon, Head Coach of the 2008 USA Men's Olympic Gold Medal Volleyball Team, sharing "The Journey to Olympic Gold." His team pulled out the feel-good story of the 2008

Beijing Olympics, upsetting Brazil in four sets to win the gold medal, and McCutcheon put his hands on his bald head and briskly walked off the court. During the first week of the Olympics, a stranger wielded a knife on his family in Beijing, killing his father-in-law and seriously wounding his mother-in-law and their tour guide while his wife watched.

California State Senator Lou Correa, who has been a long-time advocate in the state legislature for interscholastic educational athletics, will be one of the featured keynote speakers. Senator Correa, who represents the 34th California Senate District, has been honored 10 different times by various statewide organizations as "Legislator of the Year."

Additional highlights of this year's conference include the return of Jim Bracher, of the Bracher Center for Integrity in Leadership, as requested from evaluations and responses received at last year's event. Thom Simmons from the CIF Southern Section will address ways to successfully deal with the media, and CIF Executive Director Marie M. Ishida will discuss the hot topics facing administrators dealing with high school sports programs.

Bob Beale from Shasta High School, the 2008 State Athletic Director of the Year, will share his knowledge at a breakout session, as will the ever-popular Tom Barnett of the California State Teachers Retirement System.

## USC HEAD FOOTBALL COACH PETE CARROLL SPEAKS AT 33RD ANNUAL FOOTBALL PRESS CONFERENCE AND LUNCHEON

University of Southern California Head Football Coach Pete Carroll served as the keynote speaker at the 33rd Annual CIF Southern Section-Toyota Football Championship Press Conference and Luncheon held December 8th at The Westminster Rose Center.

Carroll, in his eighth year at the helm of the Trojans, was named USC's head football coach on Dec. 15, 2000. The 57-year-old Carroll has 35 years of NFL and college experience, with 19 of that on the collegiate level.

This is the second time Carroll has spoken at the luncheon. The first time was in 2002. At that time Carroll had an overall record of 16-8 and the Trojans were Co-Champions of the PAC-10 Conference. Since that time USC is 72-7, won outright or shared six more Pac-10 trophies, claimed two NCAA Championships, four NCAA Runner-up finishes, and won four Rose Bowl and two Orange Bowl titles and played in seven consecutive Bowl Championship Series games (another record). Additionally, the Trojans became the first school in NCAA history to have three Heisman Trophy winners (Carson Palmer, Matt Leinart and Reggie Bush) in a four year span. Coach Carroll is 88-15 (.854... highest among all active coaches with a minimum of five years coaching at that the Division I level) overall and 57-10 (.850) in Pac-10 Conference action. He has been named Coach of the Year twice (2003 and 2004) and Pac-10 Coach of the Year four times (2003-06).

Carroll was the head coach of the NFL's New England Patriots for 3 seasons (1997-99) and New York Jets for 1 year (1994). He guided the Patriots into the playoffs in his first 2 seasons, winning the AFC Eastern Division title at 10-6 in 1997 and advancing to the second round of the playoffs, then posting a 9-7 regular season mark in 1998. His overall record in New England was 27-21 in the regular season (including 8-8 in 1999) and 1-2 in the playoffs. He owns the franchise's second-best winning percentage (54.9%). After serving as the Jets' defensive coordinator for 4 seasons (1990-93), he became the team's head coach the following season. His 1994 Jets went 6-10. Only 3 other Jets head coaches won more games in their rookie campaign.

He spent the next 2 years (1995-96) as the defensive coordinator with the San Francisco 49ers, who won the NFC Western Division title both seasons. The 49ers were 11-5 in the 1995 regular season when they had the NFL's top-ranked defense and then went 12-4 in 1996.

Carroll began his coaching career at the college level, serving as a graduate assistant at his alma mater, Pacific, for 3 years (1974-76), working with the wide receivers and secondary. He then spent a season each as an assistant in charge of the secondary at Arkansas (1977) under Lou Holtz as the Razorbacks won the 1978 Orange Bowl, at Iowa State (1978) under Earle Bruce (the Cyclones played in the 1978 Hall of Fame Bowl) and at Ohio State

(1979) under Bruce. That Buckeye squad lost to USC in the 1980 Rose Bowl. He next spent 3 seasons (1980-82) as the defensive coordinator and secondary coach at North Carolina State, and then returned to Pacific in 1983 as the assistant head coach and offensive coordinator. He entered the NFL in 1984 as the defensive backs coach of the Buffalo Bills, and then held a similar position with the Minnesota Vikings for 5 seasons (1985-89). The Vikings advanced to the playoffs his last 3 years there, getting to the NFC Championship game in 1987. The 1988 team was 11-5 in the regular season and the 1989 squad won the NFC Central Division crown with a 10-6 mark. His secondary averaged 25 interceptions a season and led the NFL in passing defense in 1989. Carroll spent the 2000 season as a consultant for pro and college teams, doing charitable work for the NFL and writing a column about pro football for CNN.com. Carroll was a 2-time (1971-72) All-Pacific Coast Conference free safety at Pacific and earned his bachelor's degree in 1973 in business administration. He received his secondary teaching credential and a master's degree in physical education from Pacific in 1976. He was a 3-sport (football, basketball and baseball) standout at Redwood High in Larkspur, Calif., earning the school's Athlete of the Year award as a senior. He played quarterback, wide receiver and defensive back. He then played football at Marin Junior College in Kentfield, Calif., in 1970. He was born on Sept. 15, 1951 in San Francisco.

"Staying abreast of the newest and latest trends in educational athletics is a requirement for today's athletic administrator," said Ishida. "These opportunities for professional growth and instruction make the CSADA Conference a must for everyone involved in high school sports in California."

All 10 CIF Section Commissioners will again lead question and answer sessions specifically for attendees from their respective Sections and, in addition, Pete Saco, CIF Sacramento Section Commissioner, also will lead a breakout session. An NCAA

representative will report on the "NCAA Eligibility Center" and NCAA requirements, and Roger Blake, CIF Associate Executive Director, also will lead sessions.

seeks to sanction soccer programs with more than 5 red cards per season. It is specific to a level (ie: Frosh-Soph, JV or Varsity) at each site; not the program as a whole. There was some concern regarding double yellow card ejections that are reported as red cards however, 76% of the red cards reported to the CIF-SS office last year were straight red cards for fighting, misconduct, major acts of disrespect and/or fighting. Based on the last few years, there were 19 schools that would have been put on a probationary status (as they had 5 red cards in the season) with only 1 of those teams reaching 8 red cards. There were 2 lower level teams that reached or exceeded 5 for the season.
